# 2. Late night shuttles

- a. After 6PM, Blue line and Orange line perform todoor service after prospect and sachem
- b. It means door not the intersection near your house.
- c. Always gets back on the route at the specific stop.
   (Blue Whitney and Humphrey; Orange Edwards and Orange)
- d. Text service on the app, does not work, is not real

### 3. Door to door shuttle

- a. Before 1AM
  - i. Will not take you to union station.
  - ii. Will take you to Phelps gate instead to catch Blue line.
- b. Picking up from union station after 1AM
  - i. You are allowed to call from Milford.
  - ii. If there are delays, it will not wait for you beyond the normal 3 minutes.
- c. Dispatchers should not make you take a fixed route unless you are directly on the shuttle line.

### 4. To-door shuttles

- a. Law school and med school.
- b. Not restricted to any students.
- c. Will not check credentials.
- d. Should never tell you to take the next one.
- e. Should be able to get on the bus whenever.

## v. Questions

- 2. The bus drivers don't know what they are supposed to do? Get everyone on the same page?

  - a. We discussed this with Yale transit people.

  - d. They are gathering information about routes through the getting around campus documents.
- 4. Colton Can you get on the to-door shuttle as it's going?
  - a. Yes, if you flag them down and they stop.
- 5. Rattling of the handicap equipment?
  - a. Working on upgrading all the buses to a new system that is better all around.
- 6. Daisy They sometimes swap out big blue or orange shuttles during bad weather? It creates problems when trying to commute during the busy hours.
  - a. Not sure about that.
- 7. Why can't people stand on the small shuttles?
  - a. Not sure.
- 8. Joseph what's the policy for the door-to-door if you call for one? Can another person get on?
  - a. Yes technically you can, if they have room on the shuttle.
  - b. Yes, if they know they will have access
  - c. Maybe they should but they have to reroute everything else.

- 9. West Campus communication poor between the transit and west campus?
  - a. Ed is working on that.
  - b. Can track when the shuttle leaves a stop.
- 10. Can there be a separate line to cancel a door-to-door shuttle? Sometimes, have to wait for a long time on hold. Or if we could text to cancel...
  - a. Good idea.
  - b. Will address that.
- 11. Will could they use a van instead of a small bus to get to West campus during the day? Every twenty minutes is unnecessary?
  - a. They are trying to provide easy transit between the two campuses.
  - b. Especially between med school and West campus.
  - c. Green line doesn't have to run as often?
- 12. Blue weekend smaller bus since there are so few riders?
- 13. Any chance they will run at a regular schedule as in the bus leaves from this stop at this time?
  - a. Not for most of the routes.
  - b. Some buses do have specific times that they leave.
  - c. To-door shuttles on top and bottom of the hour.
  - d. Blue night leaves every fifteen minutes from Humphrey and Whitney starting on the hour.
